### PUBLIC NOTICE D01-200-23

# PROPOSED MODIFICATION OF THE ROUTE 35 BRIDGE BETWEEN THE BOROUGH OF RED BANK AND TOWNSHIP OF MIDDLETOWN, NEW JERSEY

All interested parties are herein notified that the Commander, First Coast Guard District, has received application materials from the New Jersey Department of Transportation (NJDOT) dated, October 2022 for approval of location and plans for the modification of a bridge over a navigable waterway of the United States.

**BRIDGE, WATERWAY AND LOCATION:** The Route 35 Bridge (AKA Cooper's Bridge) across the Navesink River, river-mile 8.3 between the Borough of Red Bank and Township of Middletown, Monmouth County, New Jersey.

CHARACTER OF WORK: Replace the existing fixed bridge fender system by removal of all existing (creosote coated) timber piles to a minimum depth of 3 feet below the mudline with the exception for the existing timber piles that have conflicts with the proposed fender piles shall be removed entirely, and the removal and replacement of all waler cross sections. Lighting and tidal gauges will be upgraded. The proposed project will significantly decrease the substructure rating and potentially provide greater protection to the bridge structure from vessel allisions. The new integral system will have a slightly wider channel opening. The fender will be constructed using composite polymer walers affixed to the existing 54-inch diameter concrete bridge support piles and 12, 36-inch diameter hollow fiber reinforced polymer dolphin piles. The proposed dolphin piles will be installed using both a vibratory and impact hammer.

#### **MINIMUM NAVIGATIONAL CLEARANCES:**

The proposed modified bridge will have clearances at mean high water (MHW) as described in the table below with a slightly wider channel opening.

#### **ENVIRONMENTAL CONSIDERATIONS:**

The Federal Highway Administration (FHWA) is the lead federal agency for satisfying the requirements of the National Environmental Policy Act (NEPA). The FHWA is acting on behalf of the USCG for all environmental control laws. A Categorical Exclusion dated, June 24, 2022 was issued on July 11, 2022, pursuant to NEPA, as amended. The U.S. Coast Guard tentatively determined that the proposed action will not have a significant impact on the environment for the purposes of NEPA and plans to issue a categorical exclusion for the project.

The project is not considered an encroachment on the 100-year floodplain. The project will have no effect on the low steel of the bridge at 8 feet at Maximum Elevation; and a Mean High Water (MHW) elevation at +1.83 feet and a Mean Low Water (MLW) elevation at -1.68 feet.

A water quality certification in accordance with 401 of the Clean Water Act, as amended, for this project was issued by the State of New Jersey Department of Environmental Protection Watershed & Land Management dated, December 2, 2022. No wetlands will be taken or affected by this project.

The project would "not result in adverse effects" as described in Section 106 of the National Historic Preservation Act of 1966, determination issued by the Historic Preservation Office, New Jersey Department of Environmental Protection dated, September 02, 2021.

#### **SOLICITATION OF COMMENTS:**

Mariners are requested to comment on the proposed navigation clearances, placement of a bridge protective system and other navigational safety issues, including need for clearance gauges and extent of nighttime navigation to determine the need for bridge lighting.

Interested parties are requested to express their views, in writing, on the proposed bridge project including its possible environmental impacts to include those impacts on minority and/or low-income populations, if any, giving sufficient detail to establish a clear understanding of the reasons for support of, or opposition to, the proposed work. Comments will be received for the record at the address noted in the header or via email at SMB-D1Boston-Bridges-PublicNotices@uscg.mil through June 13, 2023.










