THREE RIVERS FEASIBILITY STUDY – ECONOMIC SURVEY MCCLELLAN-KERR ARKANSAS RIVER NAVIGATION SYSTEM

The Little Rock District Corps of Engineers and the Arkansas Waterways Commission are conducting the Three Rivers Feasibility Study, which is assessing long-term solutions to erosion near the Montgomery Point Lock and Dam (river mile 0.5) at the confluence of the Arkansas, White and Mississippi rivers.

As part of the study, we will be conducting a survey of shippers along the McClellan-Kerr Arkansas River Navigation System (MKARNS) to gauge the economic effects of a potential disruption in navigation through the area near Montgomery Point Lock and Dam due to a breach in river containment structures separating the Arkansas and White rivers.

Representatives of the Corps will be visiting terminals and businesses in the next several weeks to conduct this survey. This navigation notice is to notify all interested parties of the survey. We ask that you share this notice with any interested stakeholders.

Please note that the survey is voluntary, and any specific information will be held in strict confidence, and under federal law (5 U.S.C. Sec. 552 b.4) any proprietary data provided is exempt from Freedom of Information Act (FOIA) requests. Information provided will not be reported for individual survey respondents in the feasibility study report, and the Corps will not release survey data from individual firms to the public.

COFFERDAM STABILIZATION CHICKAMAUGA LOCK TENNESSEE RIVER MILE 471.0

Rembco Geotechnical Contractors, Inc., will begin work on the lower approach cofferdams for the Chickamauga Lock Replacement Project from 28 March, 2016 to 31 August, 2016.

Rembco will be using three barges, one push boat, and one water taxi in the construction. No modifications or restrictions will be placed in the navigation channel. All mooring lines and barges will remain clear of the navigation channel at all times unless traversing to the shore during a coordinated move. CONTRACTORS MOVEMENT AND WORK PLAN

- Adequate planning and communication between the Site Superintendent and the Lockmaster shall ensure that the execution of work will not impede navigation through the project site.
- No modifications or restrictions will be placed in the navigation channel. All mooring lines and barges will remain clear of the navigation channel at all times unless traversing to the shore during a coordinated move.
- No cofferdams, camels, fender piles, dredging equipment, scows, and conveyors are planned for use during the work. The only support vessels to be used are the water taxi and the twin-screw push boat.
- Barge traffic back and forth from land will coordinate movements with the lockmaster prior to each crossing of the navigation channel.
- Movement of the water taxi will be coordinated with the lockmaster to avoid impeding navigation.
- The crane barge will remain on station clear of the navigation channel day and night. The crane boom will be secured clear of the navigation channel during non-working hours.
- The ferry barge and push boat will be moored during non-working hours as shown in attached drawing. Work on site is day-shift only.
- Ferry barge shall have solar d-beacon 6 series navigation lights positioned according to the rules of navigation rule 30(j)
- A warning sign approximately 2' x 3' shall be placed near the boat ramp to warn mariners that they are approaching a construction area.
- Typical work hours are Monday through Friday, 7am to 7pm with occasional weekend work.

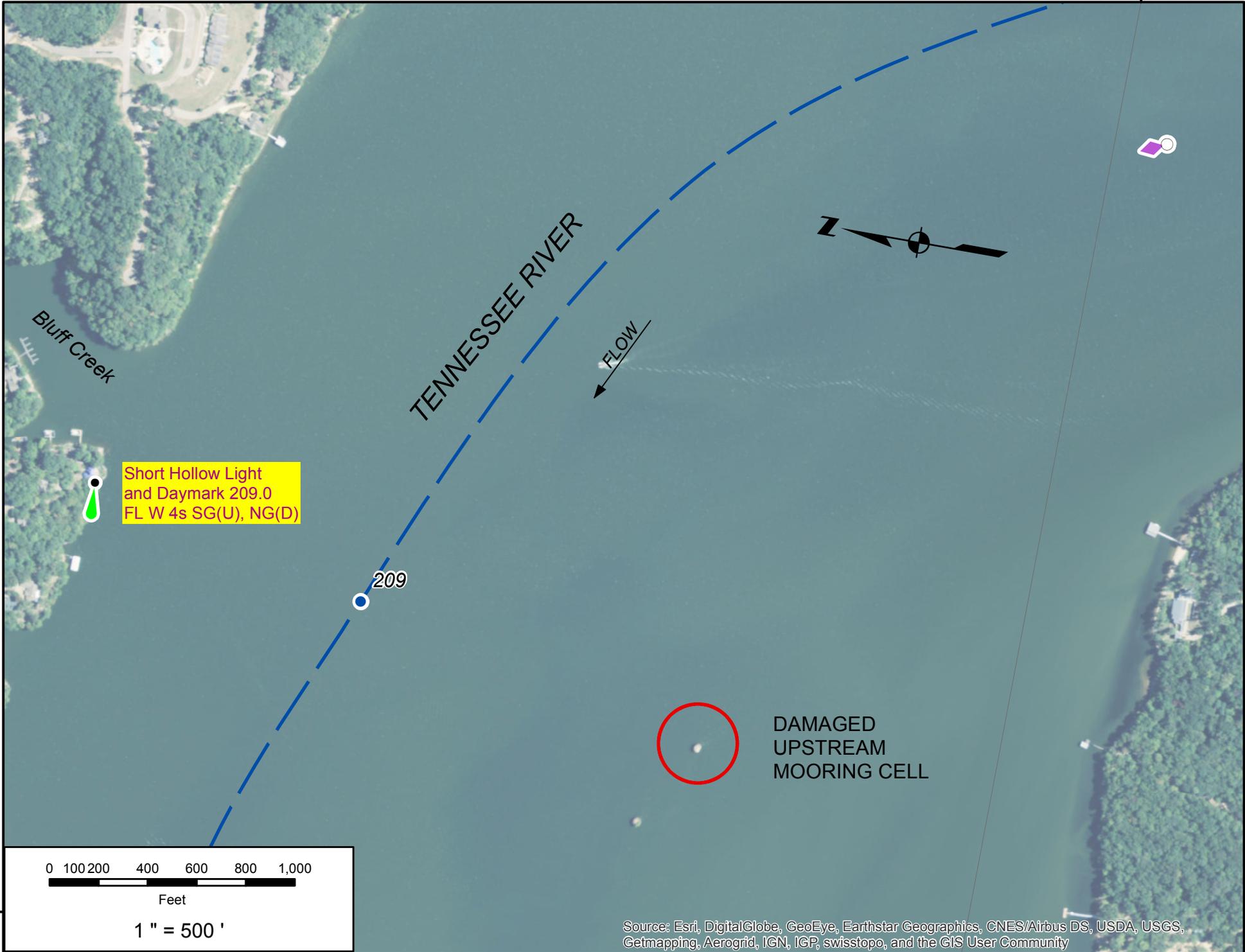
