### PRELIMINARY PUBLIC NOTICE 11-165-2025

The United States Coast Guard is soliciting public comments on a proposal by the California Department of Transportation (Caltrans) with plans for the modification of a highway bridge across a navigable waterway of the United States. A Coast Guard Bridge Permit application has not yet been submitted but would be required for this project.

**BRIDGE NAME, WATERWAY AND LOCATION**: West span of the San Francisco-Oakland Bay Bridge across San Francisco Bay, mile 8.9, between the City and County of San Francisco and Yerba Buena Island, California.

<u>**CHARACTER OF WORK</u></u>: The existing bridge fender system at piers B (W2), C (W3), D (W4), and E (W5) would be removed and replaced. The proposed work would include complete removal of the existing wooden, plastic, and steel fender elements; partial removal of the existing reinforced concrete skirt; and construction of a replacement fender system with a modified reinforced concrete skirt. The proposed replacement fender system would reduce the horizontal clearance of the bridge by 3.6' in spans B-C, C-D, and D-E; and 1.8' in spans A-B and E-YBI. The proposed project will not affect the existing vertical clearances.</u>**

Mariners and maritime stakeholders are requested to comment on navigational access and safety issues associated with the reduction in horizontal clearance in the spans of the bridge.






