In addition, the Coast Guard has approved a temporary deviation that governs the operating schedule for the 1st Avenue South Bridge (BRDG UID 29458). This deviation accommodates repair maintenance and part replacement from 6 a.m. July 14, 2026, to 11:59 p.m. January 8, 2027. From Monday through Friday, except all Federal holidays, from 6 p.m. to 6 a.m., all vessels requiring a draw opening of the 1st Ave. Bridge shall give a 24-hour advance notice and confirm their arrival time 2 hours before their scheduled arrival at the bridge. On Saturday and Sunday, during all hours of operation, vessels requiring the draw of the 1st Ave Bridge to open shall give a 24-hour advance notice and confirm their arrival time 2 hours before their scheduled arrival at the bridge. Upon the vessel's arrival, a signal shall be given to open. The bridge operator will open half of the draw in single leaf unless a full opening is requested during the 24-hour advance notice. The horizontal clearance with a full opening is 120 feet at the ends of the span and 145 feet at the water line. The horizontal clearance with half of the draw open is 60 feet at the ends of the span and 72 feet at the water line. The subject bridge provides 32 feet for 100 feet center span, and 22 feet side spans of vertical clearance in the closed-to-navigation position above high water. No alternate route is available on the Duwamish Waterway. Throughout the duration of this deviation, the 1st Avenue South Bridge must open the full draw for emergency vessel(s) responding to a call "if" safely able to do so.
